Dannah with GMS Preliminary Report review.

o Darrin Tobin -

- On Page 51 biosolids the hazardous waste cost estimates?
 - Dannah walked through the process how its handled, but cost can't be estimated
 for a future issue. Because there is testing that would have to happen, but usually
 its facilities that have uranium process plants, or mines when that would be an
 issue.
- Second question by Darrin, was do we need to increase the sewer monthly bills to prepare for the project?
 - Dannah responded that the mandatory rate requirement won't be calculated until the loan is final and they will then go through the rate analysis process based on the loan amount. There was talk of being at the States medium rate which is at\$36.06 and Sedgwick is only \$25.36, \$5 increase shows good faith that your invested in the project.

Alan Coyne –

- Are they going to design the system with a removable large collection box?
 - We are not in the design process, but that is something we will sit down together to add that.
