Clerk's Office

• GMS needs a motion as a required step for the EIAF grant.

Motion:

Dale Jones made a motion that GMS on our behalf is completing the Energy/Mineral-Impact-Assistance-Fund-Grant (EIAF) application and is approved for submission to DOLA by the Board; Peggy Owens seconded, all in favor; none opposed, motion carried.

- Spoke with the Bond Attorney, she sent an explanation of why we must use the 2022 Audit that Scott should have done by end of April, for our Grants/Loans that require the Enterprise Status to be current. So, the 2021 financial will not work due to the \$230,000 Transfer we did from General Fund to the Water and Sewer Fund.
- Some how the Bank has the wrong Heather Moore on our Town Accounts, they have a Heather R Moore instead of me. So I need a motion to allow me to make the corrections at the bank

- o Do we have an update on the Underground Fiber Lines
 - Danny replied letting everyone know we found out that our insurance company will cover us. Our Town Attorney did create a contract for them to review, and we are just waiting to hear back from them.

Dale Jones

I would like to ask the board if during the summer I could put on a music in the park, maybe once a month. We would need permission to use the Electricity. We want to make it open to local talent to come out and provide entertainment at the Jail House Park.

- o The County is asking if Towns can contribute towards the Sedgwick County Commerce. They need assistance with he wages of Rhonda, they covered her wages all last year. Now they want the support of the Towns. The number that comes to mind is \$10,000.
 - The Board asked if we can talk with Dan Pederson to see if this amount is in our budget. Because we did set aside \$5,000 but that was for the County Recreation Center.
