## Clerk's Office -Heather Moore

- Worked on Harvest Festival
- Would like to attend two training classes are available, one on 9/19 (Budget 101) and another on 9/25 (CIRSA ADA coordinator).
  - o It was agreed this would be good to attend.
- Advertised in the newspaper requested bids for the bathroom to be remodeled. No bids have come in so far, will begin calling around to get some bids. Permission to have Wayne accept a bid if it comes in under our \$10,000 budget, that was approved at our budget meeting for the year.

#### New Business -

- Appoint new Trustee to replace Nancy Sauder.
  - o We have 60 days from resignation date to appoint someone or we must put it to vote.
  - o After some discussion, it was decided to table this till the next meeting.
  - o The Board asked the Clerks office to send an announcement and invitation letter to all town residents.
    - Want them to come to the Oct 14<sup>th</sup> meeting and give their 3min reason why they want on the board
- November 5<sup>th</sup> ballot language
  - o Melinda prepared the language for the upcoming election.

**Motion:** Jeanie Tarver made a motion to approve the ballot language, Peggy Owens Seconded. – all were in favormotion carried.

# Public hearing began at 6:45pm

- **Proposed Ordinance 08-2019:** An Ordinance Regarding the Parking, Occupancy and Use of Recreational Vehicles within the Town,
  - Want to allow on public roads, but not on commercially zoned public streets.
  - o Set time limit of 4,7 days periods per year.
  - o Fines set as first violation \$50, second violation \$100, third violation \$200, after an initial warning allowing one week to resolve the violation.

**Motion:** Troy Kinoshita made a motion to approve ordinance 08-2019 with the changes discussed, Jeanie Tarver Seconded. – all were in favor- motion carried.

- **Proposed Ordinance 09-2019:** An Ordinance Amending the Town of Sedgwick official zoning ordinance to allow Mobile Homes as a conditional use in the low-density residential district.
  - Want to add an application process for accepting and allowing a new mobile home to enter into town.

**Motion:** Jeanie Tarver made a motion to table this Public Hearing and Ordinance 09-2019 to next meeting, Peggy Owens Seconded. — all were in favor- motion carried.
